## Qualification Objective

### What does this qualification cover?

This qualification prepares learners for employment as an assistant equestrian coach. A level 1 equestrian coach is able to assist with the planning and delivery of individual coaching sessions under the direct supervision of a more qualified coach. The qualification introduces learners to the practical and theoretical aspects of assisting in the planning, delivery and evaluation of individual equestrian coaching sessions.

### Who is the qualification for?

The qualification is designed for those who wish to become involved in coaching as an assistant equestrian coach. It is directed at learners who have an interest in coaching equestrian as an assistant.

### Who supports this qualification?

The qualification is recognised as the industry standard level 1 qualification for assistant equestrian coaches by the British Horseracing Authority (BHA) and UK Coaching.

The BHA is the National Governing Body for horseracing in the UK. It exists to steer the direction of horseracing, and upskill, educate and provide valuable learning and assessment opportunities to all who are involved in the horseracing industry.

## Qualification Progression

### What future education could this qualification lead to?

The skills and knowledge developed may also be used to enable learners to progress to other industry-relevant qualifications in equestrian coaching, such as the Level 2 Qualification in Equestrian Coaching. Learners may also be able to access British Equestrian Federation regional Continual Professional Development workshops.

### What future employment could this qualification lead to?

This qualification may lead to paid employment or unpaid voluntary roles in equestrian coaching, as an assistant coach. Other roles that the learner may consider exploring include Activity Leader, Official, or Sports Volunteer.

## Qualification Achievement

### Entry Requirements for the Qualification

The recognised centre is required to conduct and evidence the initial assessment of learners to ensure that the pre-requisites to registration and certification are considered, and that the learner has the potential to achieve the qualification.

Prior to registration learners are required to:

- be accurately identified
- be at least 16 years of age
- be able to communicate effectively in English<sup>1</sup> (this includes listening, speaking, reading and writing).

Prior to certification learners are required to:

- be at least 16 years of age
- have attended a recognised safeguarding workshop (not online)
- have attended a recognised first aid workshop

How is the Qualification Achieved?
<p>To achieve the 1st4sport Level 1 Award in Equestrian Coaching, learners must successfully achieve three units: two mandatory units and the equestrian-specific pathway unit. Achievement of the qualification is normally through attendance on a programme of learning and the successful completion of the 1st4sport Assessment Tasks contained within the 1st4sport Learner Portfolio.</p>
What will be assessed?

Successful completion of all assessment criteria will result in the achievement of the qualification.</p>
How will it be assessed?
<p>This qualification contains a range of units to be completed by the learner. What workforce is needed to be able to deliver this qualification?			
<p>The recognised centre is required to have a qualified and competent qualification workforce in place which includes as a minimum.</p> <ul style="list-style-type: none"> <li>a qualification administrator</li> <li>a qualification coordinator</li> <li>an appropriately qualified coach educator</li> <li>an appropriately qualified assessor</li> <li>an appropriately qualified internal quality assurer (IQA)</li> </ul> <p>Further information on workforce requirements are available from 1st4sport Qualifications on request.</p>			

### What facilities are needed to be able to deliver this qualification?

The recognised centre is required to have one or more delivery sites which contain facilities to support the programme of learning and assessment. These must comply with health and safety regulations and have in place appropriate access arrangements. All training and/or assessment sites should include the following facilities:

- car/horse box/lorry parking
- a space for theoretical sessions to be delivered with conditions conducive to learning
- male and female changing and toilet facilities.

Further pathway specific information on facility requirements are detailed within the pathway specific Qualification Handbook, which is available from 1st4sport Qualifications on request.

### What equipment is needed to be able to deliver this qualification?

The recognised centre is required to have equipment in place to facilitate the full programme of learning and assessment which must comply with accepted health and safety practice and should include:

- first aid kit (human and equine)
- emergency phone
- an indoor classroom
- a screen, projector, laptop, speakers and flipchart.

The recognised centre must ensure all learners and persons being coached wear appropriate apparel for equestrian activities and safety clothing/equipment.

### What qualification materials support this qualification?

This qualification is supported by a number of additional documents which must be read by all relevant personnel within recognised centres offering this qualification. These include:
